Subject: Involvement of Kendriya Vidyalayas (KVs) in the National Deworming Day program 2016

Dear Sir,

The National Deworming Day (NDD) was launched by Government of India, in February 2015 as a fixed day approach to intensify efforts towards control of Soil Transmitted Helminths (STHs) among children in India. Rigorous research has shown significant gains from school based deworming programs on children's health, access to education and livelihoods. The state of Rajasthan is carrying out the *anganwadi* and school based mass deworming program since 2012 with support of Department of Health, Department of Education, ICDS, UNICEF and Evidence Action – Deworm the World Initiative.

Coverage of all school age children is important so as to ensure that children lead healthier and worm free lives. As communicated by Government of India (letters enclosed) at the time of NDD Feb 2015, KVs of Rajasthan are encouraged to participate in deworming round (NDD 2016) of February 2016. The same has also discussed with Deputy Commissioner of Kendriya Vidyalaya Sangathan, Jaipur regional office by representative of our technical assistance partner (Evidence Action-Deworm the World Initiative) in September 2015. This is requested to confirm the enclosed details of KVs in Rajasthan, which has been prepared referring to websites of Kendriya Vidyalaya Sangathan Jaipur and Agra regional offices and respective KVs. The details of KVs of Rajasthan which fall in the ambit of Agra region have also been annexed for your information.

The exact details of the program would be communicated to you in first week of December 2015. We look forward to have your continuous support in successful implementation of the program.

Soil transmitted helminths (STH) are significant public health concern for India. Around 241 million (68%) children are estimated to be at risk of parasitic intestinal worm infections. Evidence has shown detrimental impact of STH infestation on physical growth - malnutrition, undernutrition and cognitive development. Children with the highest intensity STH infections are often too sick or too tired to concentrate at school or attend school at all. High worm load has been proven to adversely affect the attendance in school. Periodic deworming can reduce the transmission of STH infections.

With an aim to intensify efforts towards STH control, it has been decided to conduct National Deworming Day (NDD) on 10th February, 2015 (Tuesday) followed by a Mop-Up round on 13th February, 2015 (Friday). On the NDD, i.e. on 10th February 2015, all children enrolled in schools in classes 1st to 12th standard would be provided Albendazole tablet and missed children would be covered on the Mop-Up day i.e. 13th February, 2015. The initiative is being launched in 12 States namely Assam, Bihar, Chhattisgarh, Delhi, Dadar & Nagar Haveli, Haryana, Karnataka, Maharashtra, Madhya Pradesh, Rajasthan, Tamil Nadu and Tripura in the first phase. On NDD all the children of age 1 - 19 years will be provided Albendazole through the platform of school and Anganwadi centers except in identified Lymphatic Filariasis endemic districts.

A detailed NDD Toolkit containing Operational framework, monitoring checklist, FAQs and Fact sheets is uploaded on NHM website. Health Department would ensure supply of Albendazole tablets, their distribution to students and reporting formats at each school and impart orientation to school teachers to generate awareness prior to 10th February through assembly sessions, Pradhan Panchs, Bal Panchayats, parents-teachers meetings etc for dissemination of messages on the benefits of deworming and consuming Albendazole tablet on the NDD.

The activities required to be undertaken at the State level in convergence between the two departments would be as under:

1. School Education Departments to coordinate with Department of Health in effective roll-out of NDD.

2. School Education Department to provide the Department of Health with the figures of enrolment so as to ensure the adequate supply of Albendazole tablets is made available.
3. Schools to disseminate the IEC material provided by the Department of Health to the school management committee members and parents.
4. The Department of Health officials/team to administer deworming tablets in schools to students.
5. Officials of both the Departments be encouraged to undertake field visits for monitoring and supportive supervision on the NDD.
6. Reporting formats filled by schools to be collected by ANMs from schools within specified timelines.

We jointly request that the State Departments of both Health and Education collectively converge together for effective implementation of NDD through platform of schools. You are also requested to hold a meeting with the departments of Health, School Education, Woman and Child Development and Panchayati Raj for effective implementation and coverage of children on National Deworming Day in Schools and Anganwadi centres.


